The Direct Debit Guarantee

This guarantee should be detached and retained by the payer

- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit St Luke's Hospice will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request St Luke's Hospice to collect a payment, confirmation of the amount and date will be given to you at the time of the request.

- If an error is made in the payment of your Direct Debit, by St Luke's Hospice or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society - If you receive a refund you are not entitled to, you must pay it back when St Luke's Hospice asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

4. Boost your donation by 25p of Gift Aid for every £1 you donate

If you are a UK taxpayer, you can boost your donation by 25p of Gift Aid for every £1 you donate. Gift Aid is reclaimed by St Luke's from the tax you pay for the current tax year. Your address is needed to identify you as a current UK taxpayer.
